## **Terms and Conditions**

1. Only the Merchandise can be ordered if the applicant can fill in the Merchandise Order Form that is available on our website – [www.breakingrecordsfitness.co.uk/merchandise](http://www.breakingrecordsfitness.co.uk/merchandise) This can be filled in online with the PDF Electronic fillable which can be saved on your computer or laptop (no need to print and send to us in person). Alternatively, if you have issues to fill it in online, we do have spare copies available so please ask us on request or to print the order form yourself at home and fill it in to hand to us in person.
2. Once you have placed an order with us, payment can be done either Bank Transfer (BACS), Card or Cash which needs to be paid before we send all orders in one bulk to our Printing Suppliers. Which we reserve the right to delay your order if you haven't paid your order in full. Invoices will only be sent to the applicant if they are paying in Cash or BACS, Card payment is not necessary for us to send invoice to you as you'll likely to receive an electronic receipt via email or text message.
3. Eligibility for the Member's Discount are as follows:
  - a. Members that are on the Yearly Membership (to sign up and officially join as a member, please visit – [www.breakingrecordsfitness.co.uk/membership-sign-up](http://www.breakingrecordsfitness.co.uk/membership-sign-up))
  - b. Sponsorship opportunities for Team/Individual Sports to its groups and/or organisations (requires an additional payment to access discounted opportunities to advertise for your members, see sponsor for more details)
  - c. Charity one off event(s) for an Individual or a Team that wish to have the #BreakingRecords Fitness Logo on their Charity T-Shirt(s) (payment is required to have this done with our Printing Suppliers, see sponsor for more details), along with in return a donation of our Merchandise T-Shirt or Vest of your choice for Free, including Member's Discount to be purchased within 3 months after the Charity event date.
4. All Merchandise Orders are placed in a bulk order every month to avoid travel costs with our Printing Suppliers on a regular basis in Norwich. All Orders can take up to 2 weeks or longer subject to warehouse stock, availability, and time it takes for our Merchandise orders to be printed and collected. If the Merchandise size and colour isn't available until a later date, we can reserve the right to ask the applicant if an alternative colour, size, or a similar Merchandise to be ordered in which this can be ordered at the earliest opportunity.
5. Sponsorship opportunities for Team/Individual Sport groups/organisations must agree to the accordance of the terms to allow full exposure advertising of our business to it's Members and Followers on social media, etc. Which in return for #BreakingRecords Fitness will be allowed to advertise the Team/Individual Sport groups/organisations on our social media, Monthly Newsletters and on our website. #BreakingRecords Fitness can decline the sponsorship opportunity at any time of the following:

- a. Team/Individual Sport groups/organisations are registered with a charity that have a set of different rules and procedures in place. May lead in not being able to advertise #BreakingRecords Fitness on a regular basis to its Members and Followers.
  - b. If the sponsorship price is set too high by a Team/Individual Sport group/organisation that may not agree to an initial price (subject with agreement for their proposal price to be deducted) to access our discounted opportunities to advertise to their Members and Followers.
  - c. If the Team/Individual Sport group/organisation that #BreakingRecords Fitness sponsors with and does not advertise on a regular basis to its Members and Followers during the season/year of the sponsorship via social media, website, etc.
  - d. If the Team/Individual Sport groups/organisations does/does not gain it's form of discounts from our sponsorship opportunity to it's Members and Followers and they have decided not to renew for another season/year, will be removed from our future mentions on social media, monthly newsletters, and website for advertising.
6. Sponsorship opportunities for one-off Charity events must agree to the accordance of the terms to allow full exposure advertising of our business to its Members and Followers towards to the Charity event date set by the individual/group that are organising to raise money for their own chosen Charity. #BreakingRecords Fitness can decline the sponsorship opportunity at any time of the following:
  - a. If an individual/group that are organising the one-off charity event that won't be able to have #BreakingRecords Fitness printed to mention for their big day of the event taking place.
  - b. If an individual/group that are organising the one-off charity that the donation price with subject to an agreement for an alternative to have our logo printed is set too high that they may not agree to an additional price for our logo to be featured on your Charity T-Shirt Sleeves on both sides with our printing suppliers.
  - c. If an individual/group that are organising the one-off charity event asks for a suitable donation only with no form of logo advertisement towards to the charity event date set.
7. Any Refunds/Exchanges will be declined by #BreakingRecords Fitness if you are unhappy with your order such as for example, the size deemed too big or small, the time it has taken to have your merchandise order printed and collected, the colour may not be suitable for your individual needs and the quality of the Merchandise already printed or product. Which if another order was placed with our printing suppliers will cost #BreakingRecords Fitness time and money to sort out. If this is the fault of the printing supplier, then this can be sorted by them at no extra cost (only if should this happen at any time). If however the merchandise order is unavailable that is beyond our control, an alternative can be given in exchange of your original order to be resolved at the earliest opportunity.
8. Our prices set for advertisement can change at anytime due to labour costs for our Printing Suppliers to order the Merchandises from the warehouse stock subject to availability and for them printing our Merchandises once they arrive for them to print as requested, which the catalogue can get updated on a periodic basis.
